1. AGREEMENT TO TERMS

14. GOVERNING LAW

These Terms shall be governed by and defined following the laws of England, UK. and yourself irrevocably consent that the courts of England shall have exclusive jurisdiction to resolve any dispute which may arise in connection with these terms.

15. DISPUTE RESOLUTION Informal Negotiations

To expedite resolution and control the cost of any dispute, controversy, or claim related to these Terms of Use (each “Dispute” and collectively, the “Disputes”) brought by either you or us (individually, a “Party” and collectively, the “Parties”), the Parties agree to first attempt to negotiate any Dispute (except those Disputes expressly provided below) informally for at least 90 days before initiating arbitration. Such informal negotiations commence upon written notice from one Party to the other Party.

Binding Arbitration



If the Parties are unable to resolve a Dispute through informal negotiations, the Dispute (except those expressly excluded below) shall be finally and exclusively resolved by binding arbitration. YOU UNDERSTAND THAT WITHOUT THIS PROVISION, YOU WOULD HAVE THE RIGHT TO BRING A CLAIM BEFORE A COURT. The arbitration shall be commenced and conducted under the rules of the London Court of International Arbitration ("LCIA") or, where applicable, the arbitration rules of the Chartered Institute of Arbitrators ("CIArb"). The relevant rules can be accessed on their respective websites. The costs of arbitration, including fees and expenses, shall be governed by the applicable arbitration rules. Arbitration may be conducted in person, through the submission of documents, by telephone, or online. The arbitrator shall issue a written decision but need not provide reasons unless requested by either Party. The arbitrator must apply the applicable law, and any award may be challenged if the arbitrator fails to do so. Except where otherwise required by the applicable arbitration rules or law, arbitration shall take place in England. Except as otherwise provided herein, the Parties may seek recourse in court to compel arbitration, stay proceedings pending arbitration, or to confirm, modify, set aside, or enforce an arbitral award.

If for any reason a Dispute proceeds in court rather than arbitration, the Dispute shall be commenced or prosecuted in the courts of England and Wales, and the Parties hereby consent to, and waive all objections based on lack of jurisdiction or inconvenient forum with respect to proceedings in such courts. The application of the United Nations Convention on Contracts for the International Sale of Goods and the Uniform Computer Information Transactions Act (UCITA) is expressly excluded from these Terms of Use.

If any part of this provision is found to be unlawful or unenforceable, then neither Party shall elect to arbitrate any Dispute that falls within the portion of this provision found to be unlawful or unenforceable. In such circumstances, the Dispute shall be decided by a court of competent jurisdiction in England and Wales, and the Parties agree to submit to the personal jurisdiction of such court.

Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

Exceptions to Informal Negotiations and Arbitration

The Parties agree that the following Disputes are not subject to the above provisions concerning informal negotiations and binding arbitration: (a) any Disputes seeking to enforce or protect, or concerning the validity of, any of the intellectual property rights of a Party; (b) any Dispute related to, or arising from, allegations of theft, piracy, invasion of privacy, or unauthorized use; and (c) any claim for injunctive relief. If this provision is found to be illegal or unenforceable, then neither Party will elect to arbitrate any Dispute falling within that portion of this provision found to be illegal or unenforceable and such Dispute shall be decided by a court of competent jurisdiction within the courts listed for jurisdiction above, and the Parties agree to submit to the personal jurisdiction of that court.

16. CORRECTIONS
